The restaurant will be independently owned and operated through a franchise agreement with Servair Abidjan, a subsidiary of Servair, the third largest airline catering and logistics business globally and the category's leader on the African continent.

'We are proud to announce the opening of the first Burger King restaurant in Ivory Coast. This opening is part of the Servair international development strategy,' said Michel Emeyriat, president and chief executive officer of Servair.
